- 1. It is my sad duty to report the passing, on January 7, 2020, of Lowell V. Hammer, Past Commander-in-Chief (1991-1992).
- He also served as the Grand Army of the Republic Highway Officer, Washington, D.C. Liaison
 Officer, National Council of Administration, Junior Vice Commander-in-Chief, and Senior Vice
 Commander-in-Chief. He was a Colonel in the Sons of Veterans Reserve. He was a Past
 Department Commander of the Maryland (now Chesapeake) Department and a Past Camp
 Commander of the Lincoln-Cushing Camp #2.
- Brother Hammer served as Commander-in-Chief of the Military Order of the Loyal Legion of the United States during 1989-1991. He is one of only four Brothers to have commanded each National organization.
- 4. His family will hold memorial services later in the year.
- 5. The Sons of Union Veterans of the Civil War's National Web Site, Social Media platforms, and the Charters of all Departments and Camps will be draped in black. And, all Brothers will attach a black mourning ribbon to their membership badges in remembrance of Brother Hammer.
